# **Dress Code (evening sessions):**

### Men:

- Men must be in coat and tie (standard or bow tie)
- Exceptions to the "tie rule" are: turtlenecks, bolo ties, ascots, jeweled collars, ruffled collars and banded collars.
- Military Dress, ethnic and/or religious attire will also be allowed.
- No outdoor jackets, shorts, sandals, flip flops, sneakers or sneaker-like shoes are allowed.
- Leather jackets (with buttons) and leather pants are allowed.
- No casual attire will be allowed. Think business attire!

#### Women:

- Women must be in a dress, cocktail dress, elegant skirt & blouse combination, pant suit with a matching jacket (think business suit), or evening pant suit ensemble.
- Military Dress, ethnic and/or religious attire will also be allowed.
- No outdoor jackets, Capri pants, shorts, flip flops, sneakers or sneaker-like shoes are allowed.
- No casual or inappropriate attire will be allowed. Think elegant attire!

# **General Rules:**

- All smoking is restricted to the designated smoking area only. A
  patio area is provided outside to the right of the ballroom.
- No profanity, loud, or lewd behavior will be tolerated.
- No firearms or other weapons will be permitted on the premises.

- Attendees must adhere to ticket restrictions regarding re entry and seating, see ticket back for details.
